Effective After One Year of Service		Company Paid	Company Subsidy	Employee Contribution
<b>Retirement / Pension</b>	Enrollment on January 1 <sup>st</sup> , April 1 <sup>st</sup> , July 1 <sup>st</sup> , and October 1 <sup>st</sup> after completing 12 months of service and at least 1,000 hours of service. DFMC contributes 10 percent of the base salary. Graduated vesting after enrollment, based on each year with 1,000 hours service during the plan year: 1 year – 25%, 2 years – 50%, 3 years – 75%, 4 years – 100%	✓
